3. A BILL OF SALE FOR THE VEHICLE OR BUY BACK LETTER FROM THE INSURANCE COMPANY.
4. A RECEIPT FOR ALL MAJOR COMPONENTS USED IN THE RECONSTRUCTION.
5. A BRIEF DESCRIPTION OF WHAT YOU DID OR HAD DONE TO MAKE THE CAR ROAD WORTHY AGAIN.
6. A VALID INSURANCE CARD LISTING THAT VEHICLE-IF REQUESTING REGISTRATION
7. VALID PA DRIVER'S LICENSE WITH YOUR CORRECT ADDRESS OR AN UPDATE CARD SHOWING THE CORRECT ADDRESS.

***THE VEHICLE MUST BE DROPPED OFF WITH ALL OF THE ABOVE REQUIREMENTS. THE COST OF THE INSPECTION IS \$200.00 PLUS TAX PASS OR FAIL. REGISTRATION IS EXTRA. SALES TAX FOR THE PURCHASE PRICE OR BUY BACK AMOUNT OF THE VEHICLE IS DUE IN FULL AT THIS TIME. ANY PARTS THAT THE TAX WAS NOT PAID ON MUST BE PAID AT THIS TIME TOO.***
